ABOUT THE ASSOCIATION WOMEN'S FORUM - TETOVO

DESCRIPTION OF THE ASSOCIATION

"Women's Forum - Tetovo" (LF) is a non-governmental, non-profit, non-partial and humanitarian association founded in January 2001 in Tetovo, with the registration number 1/2001 under the name "Albanian Women's Forum" (FAC).

Since February 2008, the name of the association has changed from "Forum of the Albanian Woman" in "Women's Forum - Tetovo".

The Women's Forum is based in Tetovo, but its activities are realized in the wider region in the North and West of Macedonia.

The Women's Forum has 39 members who are actively involved in the organization's activities. The members of the Women's Forum have experience in working with women and children. They have participated and worked on a large number of seminars and projects for educating women and children.

VISION

"Women's Forum - Tetovo" strives for the emancipation of women, especially from rural areas, self-awareness of women and raising awareness of her equal status in society, protection of human rights and gender equality.

MISION

"Women's Forum - Tetovo" is a non-governmental organization working in the North and West of Macedonia to raise women's awareness of her self-esteem, strengthening her self-esteem and unhindered integration into social trends.

MAIN GOAL

Promoting a woman as an equal partner in decision-making and contributing to the empowerment of women in taking significant roles in the development of civil society in Macedonia.

STRATEGIC GOALS AND PROGRAMS

SERVICES

Center for Free Legal Aid for the victims of domestic violence

The Center for Free Legal Aid for victims of domestic violence in Tetovo (CPP) exists and operates within the Association Women's Forum Tetovo since 2002 and offers a unique type of services of this kind in Tetovo region and the wider western part of Macedonia. The main goal of the CPP is to provide free legal advice and services for women victims of domestic violence, as well as educating and informing about domestic violence.

The services provided by the CPP are fully aligned with minimum general and specialized standards that CSOs providing specialized services for the protection of victims of domestic violence should meet. Accordingly, the work uses standardized documents such as: Rules of procedure, procedure for admission and treatment of victims of domestic violence, questionnaire for reported domestic violence, statements for use of personal data and conducting appropriate procedures for victims of domestic violence and personal security plan for victims of domestic violence.

The CPP uses a separate room that is within the office of the Association, which has its own privacy and provides a gender-sensitive environment.

The CPP is run by an expert team composed of a Coordinator and a Lawyer. The team consists of only women who, apart from the expertise in legal issues, have conducted trainings in the field of violence against women and domestic violence and are sensitized for the treatment and provision of services to women victims.

The CPP has established cooperation with other NGOs working on the protection of victims of domestic violence and with all the institutions that are responsible for institutional solution of the problem of the victim, such as: the Center for Social Work, Police office in Tetovo, the Prosecutor's Office, the Court and the hospital.

CPP adequately and in written form confirm the collaboration with signed memorandum for collaboration. In accordance with the law about prevention and protection from domestic violence CPP is a member of the multisector expert team which is coordinated by the Center for social work in Tetovo.

The Legal Aid Center works publicly and transparently and includes periodic and annual reports for its work, which are appropriately published on the web site of the Association of Women's Forum from Tetovo and has excellent cooperation with the local media for promotion of the CPP.

- Coordination of the relevant actors in network.
- Organizing at least 4 coordinative meetings in network with aim reviewing the situations and proposal of concrete measures.

- 9 women from rural areas in Tetovo region has gained knowledge and skills for communication, dealing with conflicts, self-confidence, public speech, women's rights and support for the women survivors of domestic violence.
- 94 women from the community are informed about women's rights especially for the services for support that are available for the survivors of domestic violence.

Women and girls survivors or potential victims of domestic violence in Tetovo region have improved access to services and improved attitudes for seeking help.

Activities:

- Campaign for domestic violence which includes: workshops to raise the awareness of women, distribution of posters and informative leaflets,panel discussions,etc.
- 4 cycles of workshops for introducing rights, individual development and financial literacy.
- Formation of working groups that includes service providers for the survivors of domestic violence on local level and preparation, implementation and following of multisector strategy for support and prevention of the survivors of domestic violence.

Results:

- Service providers have prepared, implemented and followed the system for support with bigger identification of survivors-refferal and gender sensitivity.
- The survivors of domestic violence have shown bigger self-confidence and personal agency that they learnt and new personal and financial skills.
- Survivors of domestic violence have gained tools and knowledge to ease up their own group for support.
- 275 members of community which take part in the workshops of the project have larger knowledge and awareness about women's rights, understanding the violence as a violence of human rights and services available to survivors of domestic violence.
- Women outlined on risk show greater attitudes for seeking help and personal agency, they show that they have gained personal, life and financial skills
- Increased informing and public dialogue for survivors of domestic viiolence in Tetovo region via different media.

Action: Informing women from rural areas from Tetovo region about their rights, services that are available on local level for them and mechanisms by which they can realize it.

Location: rural areas in Tetovo region

Duration of realization: April 2017

Target group: women from rural areas in Tetovo region which have aggravate access to information about their rights, their realization and protection.

Goal of the action: Informing women from rural areas about their rights, services that are available for them on local level and mechanisms by which they can realize it.

Donator: Consalting for strategic development and Akcija Zdruzenska within the project "Improving citizens voice especially women's voice in local decision making process" UN Women

- 8 informative presentations are held with women from rural areas in Tetovo region (Glogji, Nerashte, Golema Rechica, Bogovinje, Dzepchishte, Tearce, Shipkovica and Pirok).
- 99 women from rural areas in Tetovo region (who have aggravated access to information) are informed about their rights, the realization of these rights and opportunities for protection on local level.
- 100 leaflets are distributed among women from rural areas in Tetovo region with information about services on local level which are available to them.
